

The Congo Basin Pledge - where do the resources from Norway and Germany go?

Overview of the use of Norwegian and German funds for the protection of Congo Basin forests and peatlands

At the 2021 UNFCCC Conference of the Parties in Glasgow, 12 donors pledged to mobilise at least USD 1.5 billion between 2021 and 2025 to protect the Congo Basin forests and peatlands. Since then, reports on the implementation status of the Congo Basin Pledge have been published annually at the UNFCCC Climate Change Conference of the Parties. The most recent report, published for the Conference of the Parties in Belém, shows that donors have already mobilised 1.942 billion USD for the protection of Congo Basin Forests in the first four years and presents exemplary case studies (see <https://pfbcbfp.org/en/thematics/congo-basin-pledge>). The following tables supplement the report and provide an overview of the detailed distribution of the funds provided by Norway and Germany. This is intended to create more transparency regarding the utilisation of the funds. All funds shown in the following tables correspond to the amounts reported as part of the annual reporting, the corresponding methodology is available in the annual reports.

Le Congo Basin Pledge - où vont les ressources norvégiennes et allemandes ?

Aperçus de l'utilisation des ressources norvégiennes et allemandes pour la protection des forêts et tourbières du bassin du Congo

Lors de la Conférence des parties à la CCNUCC de Glasgow en 2021, 12 bailleurs des fonds se sont engagés à mobiliser au moins 1,5 milliard de dollars entre 2021 et 2025 pour la protection des forêts et tourbières du bassin du Congo. Depuis lors, des rapports sont publiés chaque année à l'occasion des conférences des parties à la CCNUCC pour informer sur l'état de la mise en œuvre de la Congo Basin Pledge. Le dernier rapport, publié à l'occasion de la Conférence des Parties de Belém, montre que les bailleurs des fonds ont déjà mobilisé 1,942 milliards de USD pour la protection des forêts du bassin du Congo au cours des quatre premières années et présente des études de cas exemplaires (voir <https://pfb-cbfp.org/fr/thematiques/bassin-du-congo>).

Les tableaux suivants complètent le rapport et donnent un aperçu de la répartition détaillée des fonds mis à disposition par la Norvège et l'Allemagne. L'objectif est de créer plus de transparence sur l'utilisation des fonds. Tous les fonds indiqués dans les tableaux suivants correspondent aux montants déclarés dans le cadre du rapport annuel, la méthodologie correspondante est disponible dans les rapports annuels.
